Plans at Submittal	<input type="checkbox"/> One (1) set of drawings required for all multi-family or commercial projects	
Documents at Issuance	<input type="checkbox"/> Proof of Ownership, if the ownership on Lee County Property Appraiser Website (www.leepa.org) differs from the Permit Application	
Documents Prior to Inspection	<input type="checkbox"/> Certified Copy of recorded Notice of Commencement for all jobs over \$2,500.	
Info for Installer Prior to Inspection	<input type="checkbox"/> Separate permits are required for Generators, Concrete, Asphalt or Repaving. <input type="checkbox"/> Separate permit shall be secured through the Fire Prevention division for fuel tanks and/or pollutant storage over 60 gallons, LP tanks aboveground and underground 100 gallons (420 lbs) or greater. Oxygen, compressed gas, chlorine tanks, etc. also require a separate permit to be secured through Fire Prevention. Inspections	<input type="checkbox"/> 205 Gas Rough (Interior) – Schedule once all interior piping has been completed, prior to covering <input type="checkbox"/> 215 Gas Line (Exterior) – Schedule once all exterior piping has been completed, prior to covering <input type="checkbox"/> 206 Gas/Fuel Final – Schedule once all connections are complete, appliances are installed and meter has been set
